The following Price: The price quote is an estimate, and may be adjusted for, but not exclusive to: Client delays, route changes, taxes and fees incurred, additional flight time resulting from, but not exclusive to e.g. weather conditions or ATC rerouting and the additional cost of ancillary services requested by the customer, such as catering, ground transportation. Any additional charges will be noted on the final invoice.

**Validity:** This charter reservation is valid for 48 hours; thereafter, it is subject to change without notice and Business Aviators, Inc (BA) may deem it withdrawn and invalid. Changes of itinerary and/or numbers of days of usage will invalidate this charter reservation.

**Customer's cancellation:** If a charter flight is cancelled by the customer with less than 24 hours notice; up to the value of two hours of the intended aircraft to be used may be assessed to the customer. Any expenses incurred by BA related to the flight, will be billed to the customer, regardless of cancellation notice given.

**Cancellation by Business Aviators, Inc.:** BA may cancel, delay or terminate any charter flight without liability or compensation to the customer or any other person in the event that the charter flight cannot reasonably be performed or completed due to any cause beyond BA's control (including without limitation mechanical breakdown), an act of nature or God, issuance of a TFR by the TSA, or any force majeure event, or if the safety of passengers and/or property is deemed by the pilot or BA's management to be in question. In the case of such cancellations BA shall have no obligation or liability to the customer beyond refund or prepaid deposits for such cancelled charter flights, or in case of cancellation of a segment of a charter flight, such portion of the charter price relating to the cancelled segment. In no event will BA be liable for any type of indirect, incidental or consequential damages, whether arising in contract or in tort, including without limitations, for any loss of profits, loss of revenue, loss of contract or loss of goodwill arising from the performance or failure to perform a charter flight.

**Customer responsibility:** Customer shall provide all information regarding passengers, baggage, cargo and other matters requested by BA; if not so provided, BA may refuse to proceed with a charter flight. Customer is responsible for any and all damage caused to any plane by the customer, or an employee, agent, passenger, or guest of customer, normal wear and tear excepted.

**Payment:** Customer agrees that payment in full will be made by cash, credit card or check within 10 days from date of final invoice. Checks may be made payable to Business Aviators, Inc. and delivered to PO Box 986, Gillette, WY 82717. Customer hereby authorizes BA to secure funds for this deposit and final payment by credit card holder authorization. Client also agrees that if payment is not received per the agreed upon terms, BA has the authority to utilize the credit card to collect for the past due amount plus a 3% handling charge. The aforementioned terms will not apply to customers with an established BA credit line or separate Charter Agreement.
